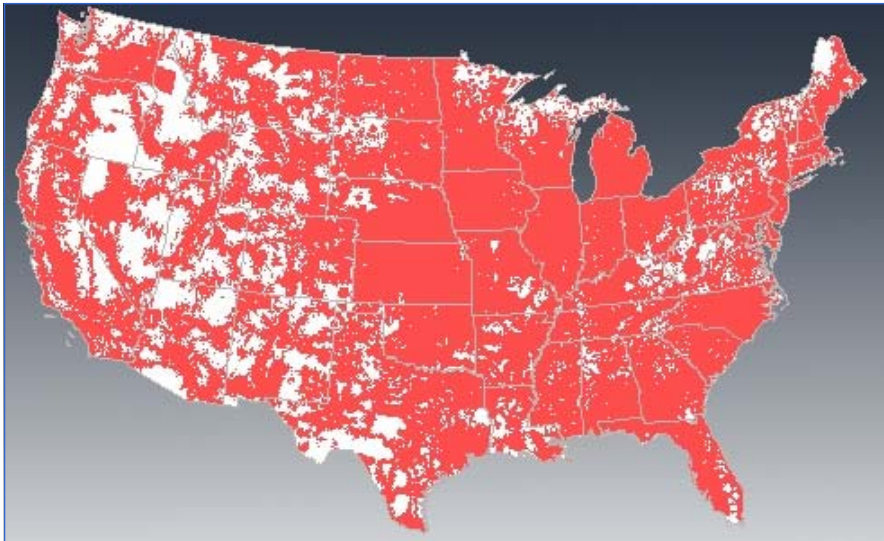

#### Sample pro-rata charging:

**Example 1:** Customer starts service February 15th.  
Annual Billing Plan will be from July 1st to June 30th.  
Months of February through June will be added to the first year of the plan.

February - 15 days	$15 \div 30 = 1/2 \times 75 =$	\$37.50
March		\$75.00
April		\$75.00
May		\$75.00
June		\$75.00
Annual		<u>\$900.00</u>
Invoice Total		\$1,237.50

**Example 2:** Customer starts service December 1st.  
Annual Billing Plan will be from January 1st to December 31st.  
Month of December will be added to the first year of the plan.

December - 30 days		\$75.00
Annual		<u>\$900.00</u>
Invoice Total		\$975.00

\*All months are treated as 30 days.
